Re: RESULTS Data Discrepancy Resolution Protocol

We are pleased to announce that a linkage has been created between the *Vegetation Resource Inventory Management System* (VRIMS) and the *Reporting Silviculture Updates and Land Status Tracking System* (RESULTS). This electronic information system linkage has been in place since September 28, 2007. Industry and BCTS electronically submit harvesting, silviculture and forest cover updates to RESULTS. This information is then shared with VRIMS through the Land and Resource Data Warehouse (LRDW). VRIMS is a toolkit for updating disturbances and changes in the provincial Vegetation Resource Inventory (VRI).

As part of the ministry's data quality assurance program, the linkage between VRIMS and RESULTS data allows selected attribute and spatial data in RESULTS to be screened for possible errors. The VRIMS inventory data quality assurance process involves:

- 1. The use of satellite imagery and ortho photography to identify spatial mapping issues;
- 2. MFR staff notifying licensee and BCTS staff about inventory data quality issues within RESULTS;
- 3. Licensees and BCTS reviewing the inventory data quality issues and providing updates or revisions to the MFR.

We suggest the implementation of a data discrepancy resolution protocol to ensure inventory data quality issues are addressed in a timely fashion. If districts do not have an inventory data quality assurance process in place, we recommend that staff use the attached protocol.

The process is intended to detect data discrepancies not identified through district compliance reviews. Only data exceeding allowable mapping and precision standards published in the *RESULTS Information Submission Specifications (RISS): Licensee Submissions*¹ should be included in the resolution protocol described in this memo.


RESULTS DATA DISCREPANCY RESOLUTION PROTOCOL

- 1. Data discrepancy is detected by:
 - a. forest inventory technicians and specialists (through VRIMS audit process); or,
 - b. any forest professionals (government or licensee staff or their consultants) engaged in field, audit or other work (e.g., surveys, silviculture, operational planning, etc.)
- 2. Person who detected the data discrepancy verifies that the discrepant data <u>exceeds</u> allowable mapping and precision standards published in the *RESULTS Information Submission Specifications: Licensee Submissions*¹; then notifies the RESULTS Coordinator of the district in which the opening resides, including supporting documentation.
- 3. District RESULTS Coordinator updates a District tracking list and identifies the licensee responsible for the RESULTS submission that contained the discrepant data. The tracking list includes:
 - a. Opening ID,
 - b. Licensee,
 - c. Name and contact info of person who reported the discrepancy,
 - d. Description of the discrepancy, including all affected fields,
 - e. Date discrepancy was reported to the ministry,
 - f. Date discrepancy notification was sent to licensee,
 - g. Date discrepancy was resolved, and,
 - h. Description of how the discrepancy was resolved.
- 4. RESULTS Coordinator prepares a letter (either email or paper) for the licensee and attaches the supporting documentation received by the person who detected the data discrepancy. A form letter (in APPENDIX A) can be used for this purpose and modified as appropriate.
- 5. Licensee reviews the information and either: 1) corrects and resubmits the data to RESULTS and notifies the RESULTS Coordinator that the data has been resubmitted; or, 2) sends the RESULTS Coordinator a justification for not correcting the data, along with supporting documentation.
- 6. RESULTS Coordinator updates the tracking list when a notification is received by the Licensee.
- 7. RESULTS Coordinator monitors the tracking list on a monthly basis to ensure resolution of discrepancies.
- 8. RESULTS Coordinator forwards a list of unresolved discrepancies to district compliance staff for investigation and action (e.g., data from submissions to the ministry on or after June 1, 2005); or, if appropriate, to the Provincial RESULTS Coordinator (<u>Caroline.MacLeod@gov.bc.ca</u>) for inclusion in future data cleaning projects (e.g., data from submissions to the ministry prior to June 1, 2005).

If discrepancies are identified through a VRIMS audit, then additional steps may be followed per the flow diagram (Figure 1). An example of a VRIMS audit process is provided in APPENDIX B.

Timely resolution of errors in RESULTS data will ensure that timber supply analyses, provincial decisions regarding forest stewardship and operations, trade and other negotiations, and annual reports to the public are based on accurate data.
